RETIREES FROM ALL CORners of the state worked diligently to help labor-friendly candidates in the November general election.

"Chapter 31 members wrote letters, addressed envelopes, walked in parades, knocked on doors, made phone calls and worked on Election Day," Sub-chapter 55 President John Weir said. "We made sure we had boots on the ground across Illinois to protect our retirement security."

The hard work paid off. JB Pritzker ousted Bruce Rauner as governor and AFSCME-endorsed candidates across the state prevailed (see page three for election details).

"I helped plan eight AFSCME Labor walks and we had great attendance," Sub-chapter 87 President David Spinner said. "Retirees also attended endorsement events, giving our members

speak with labor-friendly candidates. On the campaign trail, JB Pritzker said that he saw me everywhere. I'm glad our newly elected governor saw how active AFSCME retirees are."

And change was made. JB Pritzker and Juliana Stratton will take office on January 14.
